Lindsay,

Since the allocations are on the state fiscal year, I do not expect any expenditures for the first quarter. However, I realize that some organizations do make some expenditures prior to receiving the funds. The legislation governing these funds do not allow the agencies to release the funding until the State books are closed, and the proper paperwork is completed.

The Agency is required to collect the quarterly reports and forward the fourth quarter to EBO by June 30. The funds are typically released to organization at one time. If funds are not totally expended by the end

funds are fully expended.


If your expenditures are for normal operating one sheet will do. However, if you are providing funds to other non-profits or sub-grantees. Their use of the funds will need to be recorded individually.
