**RE:** Waiver Renewal and Waiver Amendment Training

The purpose of the memo is to notify case management providers of an important upcoming training on the Intellectual Disability/Related Disabilities (ID/RD), Community Supports (CS), and Head and Spinal Cord Injury (HASCI) Waivers as well as the death reporting policy.

The ID/RD and CS Waiver renewals and an amendment to the Head and Spinal Cord Injury (HASCI) Waiver have been approved by the Centers for Medicare and Medicaid services. Updates to the waiver manuals have been made as a result. Also, Directive 505-02-DD, which is related to death reporting, has been revised. Revisions to this directive directly impact case managers as they will now have a responsibility for reporting deaths among waiver participants in the community.

Training related to these updates and revisions will be held October 26, 2022 from 10:00- 12:00.
