SUBJECT: Continued DDSN Grant Funding of HASCI Community Opportunity Centers

The purpose of this memo is to provide an update on the progress of former rehabilitation supports (RS) providers which have converted to the provision of waiver funded day program services.

The attached monthly report reflects December utilization data. December's utilization showed a 5.4% increase in total units billed, representing the first increase in units billed since September. The total number of individuals served increased by a total of one, representing a 2% increase.

Continuation of funding will be re-evaluated in April. The expectation continues to be that providers will work toward expansion of service provision in order to achieve self-sufficiency.
