**RE: Continued DDSN Grant Funding of HASCI Community Opportunity Centers and Previous Rehabilitation Supports Providers Electing to Convert to Waiver Funded Day Program Services**

As noted in the January memo, DDSN has determined to continue funding providers at the current level through the last two quarters of this fiscal year while determining funding levels for the upcoming fiscal year. Monthly utilization report will continue to be provided to aid providers in assessing progress toward self-sufficiency.

January's usage information is attached. When compared to December's data, there was a 5.7% reduction in the number of units billed. The increase in number of individuals served across all providers was minimal at 2%.
