RE: Continued DDSN Grant Funding of HASCI Community Opportunity Centers and Previous Rehabilitation Supports Providers Electing to Convert to Waiver Funded Day Program Services

The attached monthly report reflects February's utilization data. There was a 17.8% increase in the number of individuals served. The bulk of that increase was due to the fact that one provider doubled the number of individuals served from January to February. Despite that significant increase in the number served, the same provider's number of billable units decreased by 14%. When compared to January's data, there was a 10.5 % increase in the number of units billed across all providers.

In a previous memo, it was noted that information regarding planned funding for next fiscal year would be provided by March 31, 2021. Further planning is required; therefore, notification of planned funding for fiscal year 2022 will be provided by April 30, 2021.
