Preparation:									
Identifies when medications need to be reordered and notifies appropriate person OR									
a system is in place to support the employee in re-ordering medication

Administering the medication:									
Prepares consumer for application (e.g. has consumer clear his/her nose by blowing

Puts on clean procedure gloves									
Gently shakes the medication container to mix the medication									
Rechecks label of medication to ensure medication is correct – 3rd Medication Check									
Removes the cap or cover of the medication container									
If pump bottle spray - Makes sure the pump is delivering a fine mist by squirting the									
pump into the air until a fine mist is obtained									
Instructs the consumer to keep head upright. NOTE: Some nasal medications may									
require alternate head positioning									
Asks consumer to exhale while closing off nostril with your finger on side of nose not									
receiving mediation									
Gently inserts the nasal spray bottle tip into designated nostril									
Instructs consumer to breathe in (inhale) quickly through nose and at same time									
squeezes the nasal spray bottle									
Repeat above procedure in other nostril if indicated per orders.									
Instructs consumer not to blow nose for several minutes.									
Replaces and tightens the cap on medication container									
Removes and disposes of gloves									
Washes hands
