SUBJECT: Individuals Residing in Regional Centers Desiring Community Living

Please find attached a recently updated listing of those individuals receiving services in state operated Intermediate Care Facilities for Individuals with Intellectual Disabilities (ICFs-IID), or Regional Centers, who have expressed a desire to receive residential habilitation in the community. Those individuals designated as “Strongly Desiring Community Living Arrangement (CLA)” desire to move as soon as possible. Those individuals designated as “Interested in CLA” desire to move, but are more selective in where they would move.

The attached listing includes a brief profile of individuals residing in Regional Centers who desire to move to non-ICF setting. This is intended to offer a clearer picture of their abilities. In adhering to applicable federal and state law relating to the confidentiality of personal health information, the material contained in these reports has been de-identified. Nonetheless, we urge you to be mindful of the importance of protecting the privacy of these individuals.

DDSN encourages you to seriously consider providing community residential services to those individuals, especially those individuals who have expressed a “Strong Desire for CLA.”
