RE: Continued DDSN Grant Funding of HASCI Community Opportunity Centers

The purpose of this memo is to provide an update on the progress of former rehabilitation supports (RS) providers which have converted to the provision of waiver funded day program services, and to outline the plan for continued funding through the end of fiscal year 2022.

The attached monthly report reflects August and September utilization data. After having decreased the number of units billed by about 2% per month for the previous three months, the number of units billed increased by about 7.8% from July to August and an additional 2.6% from August to September. After a 2% downturn in the number of people served for the previous three months, the number served increased by 6.7% in August, and remained at the same rate in September. This appears to reflect some growth over the past two months, and could possibly be attributed to a slight decline in positive COVID-19 cases across the state, and the comfort level of people returning to services.

As noted in the April 26, 2021 DDSN Executive Memo, DDSN committed to continuing to fund the four HASCI Community Opportunity Centers at the current level through December 2021, with the expectation that providers continue to make efforts to implement strategies aimed at self-sufficiency. The funding level was to be reevaluated after the first quarter of the fiscal year.

At this time, given the continued impact of COVID-19, DDSN has determined to continue funding the centers at the current level through the end of Fiscal Year 2022. Funding levels will be re-evaluated at the beginning of the fourth quarter of fiscal year 2022 with appropriate notice submitted to providers prior to the end of that quarter. Providers are expected to continue to work toward expansion of service provision and self-sufficiency during this time. Monthly reports will continue to be provided in an effort to assist providers with monitoring progress.
