
RE: Conflict Free Case Management – Statewide List

In accordance with 535-17-DD: Conflict Free Case Management, each DDSN Case Management provider has identified all individuals who receive both case management and direct services from their agency. This information, along with a transition plan to resolve conflict, was developed and approved for each provider during July/August 2021. This information has been compiled into a statewide list and DDSN will monitor progress on the transition framework according to the established benchmarks.

Attached you will find a map outlining the number of people per county who are currently in conflict that will need to be transitioned by December 31, 2021. Also included is chart that further breaks down the county number by funding source.

This information is being distributed to providers as information. This may be helpful in planning expansion into additional counties during the coming years/months.
