**SITUATIONAL REPORT NO. 11 DATE: APRIL 7, 2020**  
**EVENT COVID-19 PANDEMIC**

## **I. CRITICAL INCIDENTS RELATED TO COVID-19 INFECTIONS:**

Currently, eight staff have been diagnosed with COVID-19; Regional Centers (2) and community (6). Four consumers have been diagnosed with COVID-19; Regional Centers (1) and community (3).

The purpose of this interim guidance is to clarify Critical Incident reporting related to COVID-19 Infections using the following procedures:

- a) Complete an initial Critical Incident report when a staff or consumer has exhibited symptoms of COVID-19; staff or consumer quarantined; and formal COVID-19 testing sought.
- b) The report should be submitted using the Adverse Operations Event tab and selecting the type as “Public Interest/Sensitive Situations.” Illnesses are not typically reported under Critical Incidents, but COVID-19 infections will due to the significant public health risk during this State & National Emergency.
- c) The report should list the individual(s) with symptoms and the current plan of care, such as quarantine, relocation, or hospitalization. The report should also include the potential risk to other consumers or staff outside the designated setting.
- d) A final Critical Incident report is required after obtaining the COVID-19 test result. No interim mandatory reporting requirements apply—please just report upon obtaining test result.
- e) Addendum(s) will be used if symptoms persist beyond reporting a negative COVID-19 test.
- f) As DDSN tracks the COVID-19 infection data, the data will be communicated back to the provider network without attribution for situational awareness as to the impact on our community from COVID-19 during these uncertain times. This will also prevent the circulation of inaccurate information.

### **VII. EMERGENCY PROCUREMENTS AUTHORIZED:**

The State of South Carolina, as a result of the Governor's Executive Order 2020-11 Section 3, has authorized usage of the emergency procurement procedures set forth in Section 11-35-1570 of the South Carolina Code of Laws. The emergency procurements are "permitted related to purchases that are necessary and appropriate to facilitate and expedite acquisition of any critical resources during the State of Emergency". The Governor suspends the procurement regulations for purchases that "if strict compliance with the provisions thereof would in any way prevent, hinder, or delay necessary action in coping with the emergency". Providers are required to comply with SCDDSN Directive 250-08-DD "Procurement Requirements for Local DSN Boards and Contracted Service Providers" when procuring goods or services. As an interim procedure, we do hereby temporarily expand the availability of the emergency procurements to align with the Governor's Executive Order. Providers must clearly document all emergency procurements such that auditors reviewing these transactions can clearly determine that the procurement was in accordance with the intent of the Executive Order.
