## RE: Continued DDSN Grant Funding of HASCI Community Opportunity Centers and Previous Rehabilitation Supports Providers Electing to Convert to Waiver Funded Day Program Services

The purpose of this memo is to provide an update on the progress of former rehabilitation supports (RS) providers which have converted to the provision of waiver funded day program services.

The attached monthly report reflects April utilization data. There was a 16.7% increase in the number of individuals served, which can be largely attributed to one provider. When compared to March's data, there was a very minimal (0.2%) decrease in the number of units billed across all providers.

As again noted in the memo dated April 26, 2021, former RS providers are expected to develop plans to achieve self-sufficiency, and to implement those plans as DDSN's funding of these programs fades. The previously shared funding plan extends through December 2021, with continued evaluation of provider progress to occur. Each former Drop-In Center is requested to outline and implement strategies to attain self-sufficiency.
