DATE: June 16, 2023

The purpose of this memo is to notify Waiver Case Management providers of the consolidation of Personal Care and Nursing services in the DDSN Operated Waivers, and to provide notice of related training scheduled for June 28, 2023.

As announced in the May 24, 2023 Case Management Work Group meeting, SCDHHS has submitted waiver amendments to consolidate Personal Care I and Personal Care II services in the DDSN operated Community Supports (CS) and Intellectual Disability and Related Disability (ID/RD) Waivers, and to consolidate RN and LPN nursing services in the ID/RD and Head and Spinal Cord Injury (HASCI) Waivers. State Plan nursing services will also be consolidated. These changes will be effective July 1, 2023. To avoid additional strain on case managers related to the implementation of these changes, DDSN has worked ahead with Therap to plan for a migration which will update Case Management Support Plans and authorizations for these services. The migration is expected to occur June 25, 2023. Case Managers will need to review support plans and authorizations for all individuals receiving Personal Care I and II and Nursing Services to ensure the migration occurred appropriately for all individuals on their caseloads receiving these services. Please reference the attached conversion chart which outlines the previous service name and provider types, and the new consolidated service names and provider types.

Training will focus on policy and procedural revisions related to these changes and will be held virtually on June 28, 2023, from 10:00-12:00 in lieu of the regularly scheduled Case Management Work Group meeting.
