Previous Rehabilitation Supports Providers Electing to Convert to Waiver Funded

Day Program Services

The purpose of this memo is to provide an update on the progress of former rehabilitation supports (RS) providers which have converted to the provision of waiver funded day program services.

The attached monthly report reflects July utilization data. For the third consecutive month, the number of individuals served is about 2% lower than the prior month. Additionally, when compared to June's data, the number of units billed across all providers is about 2% lower.

Funding levels will be reevaluated in December of 2021. It continues to be necessary for providers to implement strategies to become self-sufficient.
