Monthly utilization reports continue to be provided as a tool to aid providers in assessing progress toward self-sufficiency and to inform the decision regarding future funding levels.

December's usage information is attached. When compared to November's data, there was an overall decrease of 18.5% in the number of individuals served across all providers. This is largely attributed to a substantial decrease in the number of persons served by one provider. In comparison to November's data, 8.2% more units were billed across all providers. This was a surprising gain given the December holidays.

DDSN has determined to continue funding providers at the current level through the last two quarters of this fiscal year. Information regarding planned funding for next fiscal year will be submitted to providers by March 30, 2021.
