RE: Continued DDSN Grant Funding of HASCI Community Opportunity Centers

The purpose of this memo is to provide an update on the progress of former rehabilitation supports (RS) providers which have converted to the provision of waiver funded day program services.

The attached monthly report reflects November utilization data. November's utilization showed a 7.1% decrease in total units billed, representing the second consecutive decrease in the number of units billed since September. Some of this may be attributed to November holidays. While the number of units billed decreased, the total number of individuals served increased by a total of two, representing a 4.2% increase.

As previously noted, DDSN will continue to fund the centers at the current level through the end of Fiscal Year 2022. Evaluation of continued funding will occur at the beginning of the fourth quarter. Providers are required to work toward expansion of service provision in order to achieve self-sufficiency in the interim.
