RE: EARLY INTERVENTION (EI) BOARD PAYMENT SYSTEM UPDATE




The March, 2019 Billing Efficiency Report of estimated billing using a per-unit rate (\$23.52) was 86.8% of the provider's current monthly prospective grant payment. The chart below sets forth this same monthly statistic for the past nine months:
