10. FY22 Spending Plan

<u>Brief Summary</u>: Mr. Maley presented the FY22 spending plan and went over the itemized increases to baseline spending plan budget line-by-line. These are new requests from DDSN staff for approximately \$4.0 increase in budget items. Discussion was held about regional center cameras and offline storage capabilities. Mr. Mickey briefed the committee on purchasing additional offline storage from the vendor we are currently using for approximately \$50 - \$60,000.

The DDSN policy currently states that camera footage needs to be kept for 60 days before it is deleted.

11. Cost Reports Update

<u>Brief Summary</u>: Mr. Maley presented a draft of the FY19 DDSN Medicaid Costs Compared to Medicaid Billable Revenue. We are currently awaiting SCDHHS revenue adjustments due to lump sum retroactive rate payments. Mr. Maley envisions cost reports for FY13, 14 and 15 will look very similar to the FY19 cost report.

Mr. Maley stated that there are three appropriations - \$10 million for residential waiver; \$7.1 million for respite; and \$12.0 million for 2.5% increase to the community and to the agency. We are looking at possible rate increases. Once we get our FTE summation from the executive budget office, then we can do an analysis. Mr. Maley is considering prepaying the funds as we continue to chase the rates.
