On motion of Commissioner Broughton, seconded by Commissioner Thompson, the Commission entered into Executive Session to discuss a legal matter.


Enter into Public Session

Commissioner Unumb moved to approve the settlement agreement drafted last week. The motion was seconded by Commissioner Neeley. The motion passed.


It was noted that Commissioner Thompson abstained from voting.
