**SUBJECT:** Continued DDSN Grant Funding of HASCI Community Opportunity Centers

The purpose of this memo is to provide an update on the progress of former rehabilitation supports (RS) providers which have converted to the provision of waiver funded day program services.

The attached monthly report reflects February utilization data. February's utilization showed a 38.7% increase in total units billed across all four providers. The total number of individuals served increased by a total of one, representing a .02% increase.

As previously indicated, continuation of funding will be re-evaluated in April. Providers are asked to continue working toward expansion of service provision and self-sufficiency.
