Previous Rehabilitation Supports Providers Electing to Convert to Waiver Funded

Day Program Services

The purpose of this memo is to provide an update on the progress of former rehabilitation supports (RS) providers which have converted to the provision of waiver funded day program services.

The attached monthly report reflects June utilization data. For the second consecutive month, the number of individuals served is about 2% lower than the prior month. Though the number of individuals served was slightly lower overall, when compared to May's data, there was a 2.9% increase in the number of units billed across all providers.

The current funding level has been approved for the five centers through December 2021, when funding levels will be reevaluated. It is necessary for providers to implement strategies to become self-sufficient during that period of time.
