RE: Day Service Delivery Reporting in Residential Settings during COVID-19

In these unprecedented times, the provider community in South Carolina has proven to be flexible, resourceful, and dedicated to the individuals served. The changes due to social distancing have taken its toll on the way services are delivered, and most providers have adapted their Day Programming to be delivered in the homes of the individuals who also receive Residential Habilitation.

In order to have a more accurate, real-time understanding of the billing of Day Programs, we are asking providers to *more regularly* document the Day Program attendance in DSAL. Providers are being asked to key the attendance for the previous week by the close of business the following Monday (Example: Key April 13th through 17th by the end of the day on Monday the 20th). DSAL should be entered, but not approved, until the normal time (the 6th working day of the month). All billing from April 1st through 10th should be entered by this Friday (April 17th). DDSN simply cannot afford to wait until the end of the month to determine the amount of services being provided. This is a vital step in assisting DDSN to fully understand the revenue impact of these changes to Day Services.

Also, attached to this Memo is a guidance sheet for completing the required documentation for provision of Day Services while in residential settings. A Therap ISP has been developed to help ensure that sufficient documentation is gathered to justify the 2-3 hour unit. If providers choose not to utilize the ISP, they should ensure that a start time and end time for the day service provision is tracked for each individual.

Delivery of Day Services in Residential Settings during COVID-19

DSAL:

In order to have a more accurate real-time understanding of the billing of Day Programs, we are asking providers to document the Day Program attendance in DSAL more regularly. Providers are being asked to key the attendance for the previous week by close of business the following Monday (Example: Key April 13th through 17th by the end of the day on Monday the 20th). DSAL should be entered, but not approved until the normal time (6th working day of the month). All billing from April 1st through 10th should be entered by this Friday (the 17th).

Documentation:

DDSN is asking all Day Services that are being provided outside of the normal locations to utilize the ISP Program titled **ISP: SC COVID 19 Supports**. This template is located in the Global ISP Template Library in Therap.

Attached is a walkthrough with screenshots of how to set up the ISP when assigning it to an individual. If that template is already assigned to an individual, please also review the attached guidance for expectations regarding time in/time out and comments reporting, as well as amending the current Day Program plan.

Comments should be used to document the specific activities, while the “scoring” will be used to show participation on behalf of the individual receiving the service. These documentation points are needed to justify billing for the service for the entire 2-3 hour unit.

Providers unable to use Therap should track the same information (time in/out, comments of activities) in a separate sheet (Excel, etc.) in order to have documentation of provision of service. If done outside Therap, staff will need to initial the documentation for verification.

Current Day Program plan objectives and ISPs can continue to be utilized if appropriate, but the start and end time of the Day Program activity should be tracked and logged somewhere that is accessible during an audit in the future.

Some ideas for participation and engagement:

- Staff provide a list for a scavenger hunt.
- Write a note, draw a picture and send to someone else.
- Call someone and talk to them. Wish them a good day.
- Go outside and find things growing. List 3 things they saw and/or tell the weather for the day.
- Talk a walk.
- Sing songs.
- Watch a YouTube video and share content with staff.
- Help with a chore(s) at home hands.
- Help wipe off door knobs, and handles at their home.
- Make a sandwich or cook something simple.
- Do a puzzle.
- Take pictures and share with staff.
- Practice folding towels or other items.
- Set an alarm to call staff back at a specified time.

Day Services Guidance: ISP: SC COVID 19 Supports

Begin Time and End Time

Time must be entered when the day services start and end.

When applying the ISP for the **first time**, under **Other Details**,

- Require Begin and End Time.
- Require Comments for data collection

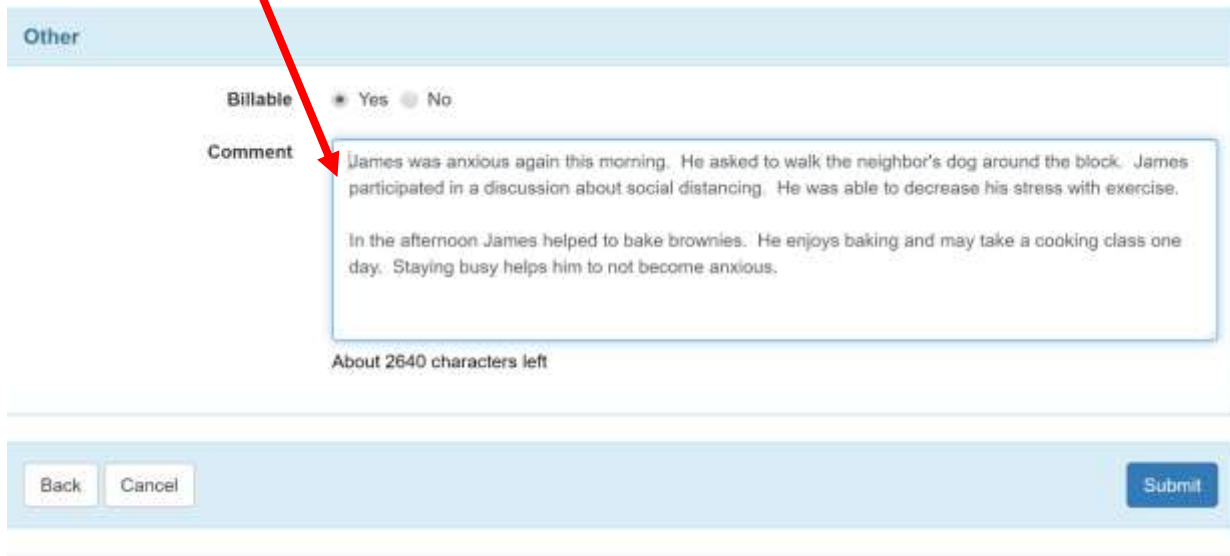

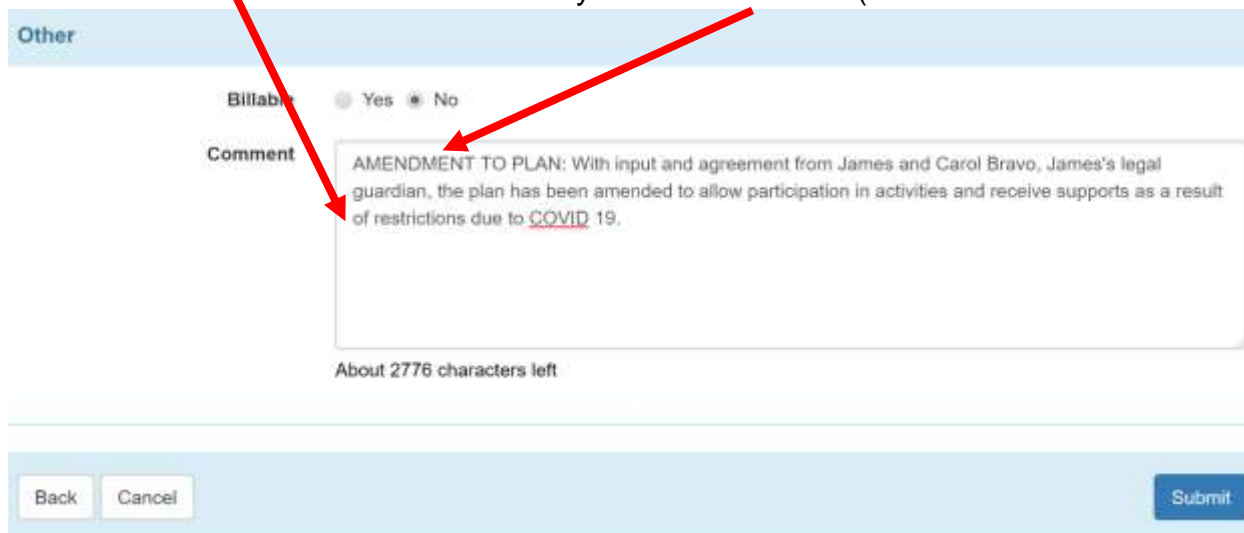
