**EVENT: COVID-19 PANDEMIC**

## **I. PFIZER/COMIRNATY BOOSTER SHOTS APPROVED FOR CERTAIN GROUPS**

On September 24, 2021 the Centers for Disease Control & Prevention (CDC) issued guidance following the Food & Drug Administration (FDA) approval of Pfizer/Comirnaty booster shot for certain populations, those 65 and older, 18 and older living in Long Term Care (LTC) settings, those aged 50-64 with underlying medical conditions, and frontline health care workers aged 18-64. These are the only populations approved for the booster shots. The CDC guidance can be found [here](#). The boosters are for Pfizer/Comirnaty recipients only. The FDA is expected to review the Moderna application for booster shots in the next two days. Information about that timeline can be found in this [article](#).

## **II. HHS ANNOUNCES PHASE FOUR OF THE PROVIDER RELIEF FUND PROGRAM**

The U.S. Department of Health and Human Services (HHS), through the Health Resources and Services Administration (HRSA), is making \$25.5 billion in new funding available for health care providers affected by the COVID-19 pandemic.
