IV. Timeline Extension from SC Labor and Licensing Regulation (SCLLR):

From the Governor's Office - SCLLR recognizes the toll that this virus is taking on South Carolinians. Director Farr and her team extended the license renewal deadline for licenses, registrations and permits scheduled to renew during the months of April, May, June, July and August. The new renewal deadline will now be extended to September 30, 2020. Additionally, continuing education requirements may be obtained throughout the entirety of this extended renewal period. Renewals will be open on their regularly-scheduled dates if licensees want to renew, but they are not required to do so. Renewing at the regularly-scheduled time may be preferable for those licensees who are required to provide proof of current licensure to other regulatory authorities or to employers. DDSN reminds residential providers of existing restricted visitation on Community Residential Care Facilities (CRCF) and Institutional Care Facilities (ICF) issued by Executive Order and DHEC guidance. Additionally, today DDSN expanded this guidance to recommend restricting visitation at all DDSN licensed facilities.

VI. DSN Board Employee Bonus Rules Relaxed:

SCDDSN has set forth requirements that Providers must follow when implementing bonus/incentive plans. Due to the COVID-19 national & state emergency, SCDDSN's goal is to provide interim procedures to give Providers as much flexibility as possible. SCDDSN is permitting Providers the latitude to develop compensation plans, to include bonuses/incentives, without requiring SCDDSN approval. Providers should ensure that any bonus/incentive structure they implement is documented, fair, and reasonable. Any payments should be focused towards those staff that are on the front lines working with consumers or staff that have work demands otherwise directly impacted by this pandemic. An example may include the need to enhance the pay for staff working in a home where a consumer or staff has tested positive for the virus. You may find it necessary to enhance pay in a variety of situations to ensure you can attract and retain staff needed to serve the consumers in your care.

DDSN cautions providers to ensure that you properly report compensation (including gift cards and other non-cash gifts) to all parties - IRS, SCDOR, SCDEW, Workers Comp, PEBA, etc. Also, please ensure costs are charged to the proper program and not to administrative costs.

Providers will be notified when the SCDDSN's bonus/incentive plan approval requirement is restored. Please let us know if you have any questions.

VIII. Tuberculosis Screening: (Click Here)

On April 3, DDSN received notification that the South Carolina Department of Health and Environmental Control (SCDHEC) is suspending tuberculin skin testing for facility staff prior to their date of hire, initial resident contact, or initial patient contact, when they meet conditional criteria. DDSN will follow this directive and waive TB Testing Requirements during the current COVID-19 State of Emergency in conjunction with the DHEC criteria.
